## **Business Scenario**

BESCOM, the electricity distribution company in Karnataka, manages a high volume of Power Purchase Agreements (PPAs) with residential producers under the PM Surya Ghar: Muft Bijli Yojana. The traditional PPA signing process was manual, time-consuming, and dependent on multiple approvals. The lack of automation, digital signatures, and seamless payment integration led to inefficiencies, delays, and high administrative overhead.

Additionally, the absence of an integrated payment gateway and e-stamping caused disruptions in agreement execution, requiring consumers to visit BESCOM offices multiple times for payments and approvals. BESCOM sought a secure, automated, and fully integrated digital signing and e-stamping solution to streamline the PPA process.

## eMudhra Solution

eMudhra provided BESCOM with its emSigner-based e-stamping and digital agreement solution, enabling a fully paperless and secure PPA execution process. The solution integrated with NeSL for e-stamping and PayU for seamless online payments, ensuring real-time validation and agreement finalization.

manual transactions.




Compliance with Regulatory Standards: The solution ensures alignment with MNRE & DISCOM guidelines for power purchase agreements.

## Solution Architecture

The solution was integrated into BESCOM's online portal, leveraging cloud-based HSMs (Hardware Security Modules) for secure certificate storage and real-time document signing. Consumers access the system via BESCOM's portal, where they complete the agreement process in the following steps:

- 1. Consumer submits PPA application and receives a unique reference number.
- 2. Agreement details are auto-fetched from BESCOM's database.
- 3. Consumer reviews, signs the agreement digitally, and completes payment via PayU.
- 4. e-Stamping is executed through NeSL, ensuring legal compliance.
- 5. BESCOM officials review, validate, and digitally sign the agreement, completing the process.
- 6. Signed documents are stored securely and shared with both parties for reference.
